DEMAND FOR JURY TRIAL

1 Plaintiff Xiamen Zhaozhao Trading Co., Ltd. (“Zhaozhao” or “Plaintiff”) hereby asserts the
2 following claims for patent infringement against Defendant SuZhou XiongXiaoDou PinPai
3 WenHua ChuanBo YouXian GongSi,
4 (“Defendant”), and alleges as follows:

5 **NATURE OF THE ACTION**

6 1. This is a civil action for patent infringement under the patent laws of the United
7 States, 35 U.S.C. § 1 *et seq.*

8 2. This action arises from Defendant’s infringement of U.S. Design Patent Nos.
9 D955,550 (“the ’D550 Patent”), and D958,465 (“the ’D465 Patent”) (collectively, “the Asserted
10 Patents”).

11 3. A copy of the ’D550 Patent and ’D465 Patent are attached as Exhibits A and B
12 respectively.

13 **THE PARTIES**

14 4. Zhaozhao is a company organized and existing under the laws of China, with its
15 principal place of business at Unit 01-170, 5/F, No. 32 2nd East Haijing Road, (Bonded Port Area),
16 Xiamen Area of Pilot Free Trade Zone (Fujian) of China, China.

17 5. On information and belief, Defendant is a company organized and existing under
18 the laws of China, with its principal place of business at B401-1, No.388 Ruoshui Road, Suzhou
19 Suzhou Industrial Park, Suzhou Area, China (Jiangsu) FTZ, Suzhou, China 215000.

20 **JURISDICTION AND VENUE**

21 6. This is a civil action for patent infringement arising under the patent laws of the
22 United States, 35 U.S.C. § 1 *et seq.*

23 7. This Court has subject matter jurisdiction over the matters asserted herein under 28
24 U.S.C. §§ 1331 and 1338(a).

25 8. Defendant is subject to this Court’s personal jurisdiction as it has committed acts
26 giving rise to this action within and/or directed to this District and has established minimum
27 contacts within this District such that the exercise of jurisdiction over Defendant would not offend
28 traditional notions of fair play and substantial justice. On information and belief, Defendant is

1 systematically directing business activities at consumers in the United States, including California,
2 through online platforms such as Amazon.com, through which consumers in the United States,
3 including California, can view, place orders for, and purchase Defendant’s infringing products for
4 delivery in the United States, including California.

5 9. Venue is proper in this judicial district pursuant to 28 U.S.C. §§ 1391 as Defendant
6 is a foreign corporation and is subject to personal jurisdiction in this district.

7 **THE ASSERTED PATENTS**

8 10. On June 21, 2022, the USPTO duly and legally issued the ’D550 Patent entitled
9 “pet house”.

10 11. The ’D550 Patent is valid and enforceable.

11 12. Zhaozhao is the sole assignee and owner of all right, title, and interest in and to the
12 ’D550 Patent.

13 13. On July 19, 2022, the USPTO duly and legally issued the ’D465 Patent entitled “pet
14 house”.

15 14. The ’D465 Patent is valid and enforceable.

16 15. Zhaozhao is the sole assignee and owner of all right, title, and interest in and to the
17 ’D465 Patent.

18 **BACKGROUND**

19 16. Zhaozhao’s innovative products include an innovative line of cat houses, which
20 Zhaozhao markets and sells in the United States through its online business Rockever.

21 17. Zhaozhao developed its innovative line of cat houses to be both durable and
22 attractive, while at the same time, providing cats with ample space to lounge, hide, and play.

23 18. Prior to Zhaozhao’s innovative line of cat houses, most cat houses on the market
24 were relatively small and did not provide cats with sufficient space and did not have multiple levels
25 or enclosed spaces.

26 19. Due to the large size of Zhaozhao’s cat houses, they are designed to be used
27 outdoors. Because of this, Zhaozhao spent considerable time and effort developing cat houses that
28 are both durable for outdoor use and attractive. The effort put in to developing the design has

1 resulted in a cat house which does not look out of place in a customer’s property, such as a front or
2 back yard, porch, or deck.

3 20. Zhaozhao has protected its innovative products and designs through intellectual
4 property rights, including through design patents issued by the United States Patent and Trademark
5 Office.

6 21. The ’D550 Patent is practiced by a Rockever product. A true and correct screen
7 shot from Amazon.com showing this product is attached as Exhibit C.

8 22. The ’D465 Patent is also practiced by a Rockever product. A true and correct
9 screen shot from Amazon.com showing this product is attached as Exhibit D.

10 23. Since Zhaozhao began selling its innovative line of cat houses, its design has been
11 copied by numerous companies, including Defendant, who sells cat houses which look just like
12 those sold by Zhaozhao.



13 24. On information and belief, Defendant sells its infringing cat houses under the name
14 Mollypaws. True and correct screenshots showing Defendant’s infringing products for sale on
15 Amazon.com are attached as Exhibits E, F, G, and H.



COUNT 2: INFRINGEMENT OF THE 'D465 PATENT

PRAYER FOR RELIEF

WHEREFORE, Plaintiff respectfully requests:

- A. A Judgment that Defendant has infringed, infringes, and continues to infringe the 'D550 Patent and the 'D465 Patent;
- B. A finding that Zhaozhao has no adequate remedy at law and an order and judgment permanently enjoining Defendant, its parent companies, subsidiaries, related companies, and all persons acting in concert or participation with Defendant, or persons acting or purporting to act on its behalf, including, but not limited to its officers, directors, partners, owners, agents, representatives, employees, attorneys, successors, and assigns, and any and all persons acting in concert or privity with them, from making, using, importing, exporting, distributing, supplying, selling or offering to sell, or causing to be sold any product falling within the scope of the 'D550 Patent or the 'D465 Patent, or otherwise contributing to or inducing the infringement of the 'D550 Patent or the 'D465 Patent;
- C. A judgment ordering the recall and destruction of all materials within the control of Defendant, its parent companies, subsidiaries, or related companies, and their agents or distributors, that in any way infringe upon the 'D550 Patent or the 'D465 Patent;
- D. An award of damages to adequately compensate Zhaozhao for Defendant's patent infringement, such damages to be determined by a jury, and an accounting to adequately compensate Zhaozhao for the infringement;
- E. An order finding that this is an exceptional case under 35 U.S.C. § 28 and awarding Zhaozhao attorneys' fees;
- F. Costs and expenses in this action;
- G. An award of prejudgment and post-judgment interest; and
- H. Such other further relief, in law or equity, as this Court deems just and proper.
