#### **COMPLAINT FOR PATENT INFRINGEMENT**

Plaintiff Onstream Media Corporation ("Onstream") files this Complaint against Defendant CafeX Communications LTD ("CafeX") for patent infringement of United States Patent Nos. 9,161,068; 10,200,648; 10,694,142; 10,848,707; 10,951,855; and 11,128,833 (the "patents-in-suit") attached as Exhibits 1-9, respectively, and alleges as follows:

#### **NATURE OF THE ACTION**

1. This is an action for patent infringement arising under the patent laws of the United States, 35 U.S.C. §§ 1 *et seq*.

This Court has personal jurisdiction over Defendant because Defendant (directly and/or through its subsidiaries, affiliates, or intermediaries including CafeX Communications Inc.) has ommitted and continue to commit acts of infringement in this judicial district in violation of at least 35 U.S.C. § 271(a).
- 7. This Court also has personal jurisdiction over Defendant because

  Defendant has sufficient minimum contacts with this forum as a result of business

conducted within the State of Texas and this judicial district. In particular, this Court has personal jurisdiction over Defendant because, *inter alia*, Defendant, on information and belief (directly and/or through its subsidiaries, affiliates, or intermediaries), has substantial, continuous, and systematic business contacts in this judicial district, and derive substantial revenue from goods and services provided to individuals in the State of Texas and this judicial district.

- g. awarding Onstream damages under 35 U.S.C. § 284, or otherwise permitted by law, including supplemental damages for any continued post-verdict infringement;

- h. awarding Onstream pre-judgment and post-judgment interest on the damages award and costs;
- i. awarding cost of this action (including all disbursements) and attorney fees pursuant to 35 U.S.C. § 285, or as otherwise permitted by the law; and
