Plaintiff Combe Incorporated ("Combe") brings this action for patent infringement against Defendant Kos Kos USA LLC d/b/a CariCare ("Kos Kos" or "Defendant"), and alleges as follows:

### **PARTIES**

1. Plaintiff Combe is a corporation organized and existing under the laws of the State of Delaware, having its principal place of business at 1101 Westchester Avenue, White Plains, New York 10604. Combe is a personal-care company founded in 1949, involved in the research, innovation, manufacturing, and sale of personal care, beauty, and healthcare products.

2. On information and belief, Defendant is a corporation organized and existing under the laws of California, doing business as CariCare, having a principal place of business at 14107 Dinard Ave., Santa Fe Springs, California 90670.

3. On information and belief, Defendant also has business addresses at 13905 Maryton Ave., Santa Fe Springs, California 90670 and 3000 W. Olympic Blvd., Suite 305, Los Angeles, California 90006.

4. On information and belief, Kos Kos transacts business within California and throughout the United States, including but not limited to marketing, distribution, sales and/or offers to sell haircare products.

## JURISDICTION AND VENUE

5. This is an action for patent infringement arising under the patent laws of the United States, Title 35 of the United States Code. This Court has subject matter jurisdiction pursuant to 28 U.S.C. §§ 1331, 1332(a) and 1338(a).

Chis Court has jurisdiction over Kos Kos because, *inter alia*, upon
 information and belief, Kos Kos has substantial, continuous, and systematic
 contacts with the State of California, and directly or indirectly manufactures,
 imports, markets, distributes, offers to sell, and/or sells products in California.
 Defendant's products include CariCare Naturally Darkening Shampoo ("CariCare

Darkening shampoo") which, as discussed in more detail below, infringes the patent-in-suit. Upon information and belief, Kos Kos derives substantial revenue from the sale, use, and consumption of its products, including the CariCare Darkening shampoo, in the State of California.

On information and belief, Defendant offers to sell and sells its 7. products, including CariCare Darkening shampoo, through a storefront on Defendant's website caricareusa.com and additional storefronts that Defendant has established, operates, and/or controls on Amazon.com and Walmart.com. Defendant's online storefronts permit customers to view, order, and purchase Defendant's products, including the CariCare Darkening shampoo.

8. Indeed, on or about January 19, 2023, two bottles of CariCare Darkening shampoo were purchased in accordance with Plaintiff's instructions from Defendant's storefront on caricareusa.com. Subsequently, on or about January 26, 2023, a shipment of two boxes, each of which contained a bottle of CariCare Darkening shampoo, was delivered. The shipment had been sent from Defendant (identified as "CARICARE OFFICIAL" on the shipping label). Each box in the shipment, as well as each bottle of shampoo inside the box, identified "KOSKOS USA LLC" as the distributor of the product and further identified Defendant's 13905 Maryton Ave. business address and its caricareusa.com website.

9. On information and belief, Defendant also offers to sell and sells its products, including CariCare Darkening shampoo, through brick-and-mortar 22 storefronts throughout this district. 23

10. Venue is proper for Defendant in this district under 28 U.S.C. §§ 24 1391(b) and (c) and 1400(b). Defendant is incorporated, and therefore resides, in 25 this district and also has committed the infringing acts in this district giving rise to 26 the infringement allegations herein. Venue is also proper in this district because 27 Defendant is subject to this Court's personal jurisdiction. 28

12. The '704 patent is owned by Combe.

13. The '704 patent relates to an air oxidation haircolor shampoo composition comprising an air oxidation hair dye; at least one cleansing surfactant; and optionally, at least one conditioning agent, where a conditioning agent content is about 0.5% to about 15% weight by weight, wherein the air oxidation haircolor shampoo composition cleanses hair, and wherein the air oxidation haircolor shampoo composition gradually colors hair with repeated use.

14. The '704 patent also relates at least to methods for gradually coloring hair comprising the steps of: a) applying an air oxidation haircolor composition to hair; b) removing the air oxidation haircolor composition from the hair directly after application; and c) repeating a set comprising steps a) and b) in multiple spaced intervals. The air oxidation haircolor composition can include a grooming agent.

## **DEFENDANT'S INFRINGING PRODUCT AND ACTIVITIES**

15. On information and belief, Defendant is engaged in the business of manufacturing, using, selling and/or offering to sell within the United States (including within this judicial district), or importing into the United States, shampoo which is covered by one or more claims of the asserted '704 patent.
Specifically, CariCare Darkening shampoo infringes claims of the '704 patent.

16. Defendant has been aware of the '704 patent since at least February 1,
2023, the date a cease-and-desist letter including this patent number was sent by
Combe to Defendant via e-mail and Federal Express. Defendant did not
substantively respond to the February 1 letter. A second cease-and-desist letter

including the '704 patent number was sent by Combe to Kos Kos via e-mail and
 Federal Express on March 3, 2023. Defendant's infringing acts, including the
 operation of its online storefronts, has continued.

#### COUNT I

## **INFRINGEMENT OF THE '704 PATENT**

17. Combe incorporates and realleges paragraphs 1-16 above, as if set forth specifically here.

18. Combe's claim arises under the Patent Laws of the United States, 35U.S.C. § 271.

19. Defendant has directly infringed and is directly infringing the '704 patent by manufacturing, using, selling and/or offering to sell within the United States and/or importing into the United States the CariCare Darkening shampoo embodying the invention defined by one or more claims of the '704 patent, without authority of Combe. More particularly, Defendant's manufacture, use, sale and/or offer for sale in the United States and/or importation into the United States of the CariCare Darkening shampoo infringes at least claims 18-21 and 23 of the '704 patent.

On information and belief the CariCare Darkening shampoo is an air 20. 18 oxidation haircolor shampoo composition which contains, among other 19 ingredients, Water, Sodium C14-16 Olefin Sulfonate, Lauryl Glucoside, Disodium 20 Laureth Sulfosuccinate, 1,2,4-Trihydroxybenzene, Sodium Chloride, 21 Polyquaternium-10, Menthol, Salicylic Acid, Chlorphenesin, Panthenol, Caramel, 22 Allantoin, Citric Acid, Glycyrrhiza Uralensis (Licorice) Root Extract, Zingiber 23 Officinale (Ginger) Root Extract, Schizandra Chensis Fruit Extract, Coptis 24 Japonica Root Extract, Propolis Wax, Butylene Glycol, Glycerin, Capryl Glycol, 25 Lycium Chinese Extract, Propanediol, Ricinus Communis (Castor) Seed Oil, 26 Camellia Sinesis Leaf Extract, Asiaticoside, Tannic Acid, Gallic Acid, Biotin, 27 Camellia Japonica Seed Oil, Camellia Sinensis Seed Oil, Camellia Japonica 28

21. On information and belief the CariCare Darkening shampoo has an air oxidation hair dye, including but not limited to: 1,2,4-Trihydroxybenzene.

22. On information and belief the CariCare Darkening shampoo has at least one cleansing surfactant, including but not limited to: Sodium C14-16 Olefin Sulfonate, Lauryl Glucoside, Disodium Laureth Sulfosuccinate.

23. On information and belief the CariCare Darkening shampoo
optionally has at least one conditioning agent at a content of about 0.5% to about
15% weight by weight, including but not limited to: Polyquaternium-10.

24. On information and belief the CariCare Darkening shampoo cleanses hair.

25. On information and belief the CariCare Darkening shampoo gradually colors hair with repeated use. The CariCare Darkening shampoo packaging contains images showing how repeated use achieves gradual darkening.



26. On information and belief the CariCare Darkening shampoo has at

not limited to: Sodium C14-16 olefin Sulfonate, Disodium Laureth Sulfosuccinate,
Lauryl Glucoside.

27. On information and belief the CariCare Darkening shampoo has at least one conditioning agent, including but not limited to: Polyquaternium-10.

28. On information and belief the CariCare Darkening shampoo has at least one anti-dandruff agent, including but not limited to: Salicylic Acid.

29. On information and belief the CariCare Darkening shampoo has 1,2,4benzenetriol.

30. On information and belief, the CariCare Darkening shampoo simultaneously grooms, cleans, conditions, and gradually colors hair with repeated daily use. Kos Kos states on its website and on its CariCare Darkening shampoo packaging that its Darkening shampoo has "amazing effects in four weeks." Additionally, the CariCare Darkening shampoo packaging contains images showing how repeated use achieves gradual darkening.



31. Kos Kos is also indirectly infringing the '704 patent at least by virtue
of its inducement of direct infringement of that patent by customers who use the
CariCare Darkening shampoo. Kos Kos has been aware of the '704 patent since at

least February 1, 2023. On information and belief, Kos Kos knowingly induces
customers to use the CariCare Darkening shampoo, including, for example, by
promoting it to be used in an infringing manner and/or providing customers with
instructions for using it in an infringing manner. Thus, Kos Kos induces
infringement of at least claims 1-6, 9-11, 13-17, and 24-25 of the '704 patent under
35 U.S.C. § 271(b). Combe is unaware of any substantial non-infringing uses of
the CariCare Darkening shampoo, and therefore the marketing of the CariCare
Darkening shampoo will contribute to infringement of at least claims 1-6, 9-11, 1317, and 24-25 of the '704 patent under 35 U.S.C. § 271(c).

32. Kos Kos instructs its customers on the CariCare Darkening shampoo packaging to "Wet your hair and scalp with water;" "Apply shampoo generously, lather, and massage with your fingers for about 3 minutes;" and "Rinse thoroughly with warm water." Kos Kos further instructs its customers to use the shampoo daily and informs users that the effects will gradually be seen over four weeks.

On information and belief, Defendant's infringement of the '704 33. 15 patent has been willful, intentional, and deliberate. Kos Kos has had actual 16 knowledge of the '704 patent and actual knowledge that the CariCare Darkening 17 shampoo infringes one or more claims of the '704 patent since at least February 1, 18 2023, the date a cease-and-desist letter including this patent number was sent by 19 Combe to Kos Kos via e-mail and Federal Express. Further, a second cease and 20 desist letter including this patent number was sent by Combe to Kos Kos via e-mail 21 and Federal Express on March 3, 2023. In addition, the filing of this Complaint 22 provides actual notice to Kos Kos of the '704 patent under 35 U.S.C. § 287 and the 23 infringement as alleged here. On information and belief, Kos Kos has willfully 24 infringed, and continues to willfully infringe, the '704 patent by continuing to 25 make, use, offer for sale, sell, or import the CariCare Darkening shampoo in the 26 United States and by continuing to induce infringement and contribute to 27 infringement of that patent by customers who use the CariCare Darkening 28

34. Combe contends that each element of each asserted claim is literally present in the CariCare Darkening shampoo. If, as a result of the Court's constructions or other determinations, one or more claim elements are not literally present, Combe contends that each such element is present under the doctrine of equivalents and reserves its right to provide more detailed doctrine of equivalents contentions after discovery, a claim construction order from the Court, or at another appropriate time.

35. Defendant's acts complained of herein are damaging and will continue to cause irreparable injury and damage to Combe for which there is no adequate remedy at law. Combe is therefore entitled to a permanent injunction restraining and enjoining Kos Kos from infringing the claims of the '704 patent.

36. By reason of Defendant's infringing activities, Combe has suffered, and will continue to suffer, substantial damages in an amount to be determined at trial.

# **Prayer for Relief**

WHEREFORE, Combe prays for judgment and relief as follows:

A. That Kos Kos has infringed the '704 patent;

B. That Kos Kos and its subsidiaries, affiliates, officers, directors, agents, servants, employees, successors, and assigns, and all other persons and organizations in active concert or participation with them, be permanently enjoined from further acts of infringement of the '704 patent pursuant to 35 U.S.C. § 283;

C. That Kos Kos be ordered to pay damages adequate to compensate
Combe for its infringement of the '704 patent pursuant to 35 U.S.C. § 284,
including lost profits and/or a reasonable royalty, together with interest thereon;

D. A judgment declaring that Kos Kos' infringement has been willful and awarding enhanced damages under 35 U.S.C. § 284;

E. A declaration that this is an exceptional case under 35 U.S.C. § 285
