I am looking to enjoin the department of vital statics from profiting from the sale and to return the original to the principal owner, which is me, the true beneficiary of the document and of the proceeds from the sale of counterfeit documents etc. I also demand treble damages in accordance with damages under section 284, attorney fees under 285 and additional remedy for infringements or design patent under section 289. I also wish to enjoin all corporation state and federal, from profiting from my intellectual property. I feel that this case should be granted in my favor through summery judgement because the opposite would be to consider that I am a slave to these government(s) organizations and who ever pays for the rights to tax the entity on the document. I believe slavery is outlawed in this country, I move this court to approve summery judgement in this matter, anything else with be unethical and aid in violation of the Lanham act 1881.
