22	1. This is an action for patent infringement arising under the Patent Laws of the

the Defendants for infringing U.S. Patent No. D965,668 (the "'668 Patent''). A true and accurate copy of the '668 Patent is attached hereto as Exhibit 1.

THE PARTIES

- 2. Plaintiff Ji is an individual who is a citizen and resident of the People's Republic of China.
- 3. Upon information and belief, the Schedule A Defendant is an individual or business entity of unknown makeup who own and/or operate one or more of the ecommerce stores under the seller alias identified in Schedule A attached hereto. Upon information and belief, the Schedule A Defendant resides and/or operates in the People's Republic of China or other foreign jurisdiction(s). The Schedule A Defendant has the capacity to be sued pursuant to F.R.C.P. 17(b).
- 4. Tactics used by the Schedule A Defendant to conceal its identity and the full scope of its operation make it virtually impossible for Plaintiff to discover the Schedule A Defendant' true identity and the exact interworking of its network. If Plaintiff obtain additional credible information regarding the Schedule A Defendant's identity, Plaintiff will take appropriate steps to amend this Complaint.
- Upon information and belief, Defendant Amazon.com is a Delaware corporation with its principal place of business at 410 Terry Avenue North, Seattle, WA, 98109. Defendant Amazon.com may be served through its registered agent Corporation Service Company at 300 Deschutes Way SW Ste 208 MC-CSC1, Tumwater, WA, 98501.

JURISDICTION AND VENUE

- This Court has original subject matter jurisdiction over the claim(s) in this Action pursuant to the Patent Laws of the United States, 35 U.S.C. § 1 *et seq.*, including 35 U.S.C. § 271. 28 U.S.C. §§ 1331, 1338(a)-(b).
- 7. This Court has personal jurisdiction over the Defendants because each of the Defendants has committed one or more of the infringing acts complained herein in California and in this District. Upon information and belief, each of the Defendants place infringing products in the stream of commerce with the knowledge, understanding, and expectation that such products will be sold and/or used in



California and in this District. On information and belief, each of the Defendants derives and continues to derive substantial revenue from the sale of infringing products in this district in interstate and international commerce and expects its action to have consequences in this District, which encompass a substantial portion of the events giving rise Plaintiff's claims.

8. Venue is proper in this Court pursuant to 28 U.S.C. §§ 1391 and 1400(b). For the Schedule A Defendant, upon information and belief, the Schedule A Defendant resides and/or operates in the People's Republic of China or other foreign jurisdiction(s). For Defendant Amazon.com, upon information and belief, Defendant Amazon.com maintains and operates at least one office, warehouse, and/or other regular and establish place of business in this District.

FACTUAL ALLEGATIONS

9. The '668 Patent, entitled "Annular Remote Control Photography Supplement Lamp", was filed June 3, 2020 and duly issued by the U.S. Patent and Trademark Office on October 4, 2022. Plaintiff Ji is an inventor and owner of the '668 Patent at all times during the Defendants' infringements of the '668 Patent. The patented design of the '668 Patent is shown below:





12. During the term of the '668 Patent, under listing B09GVSKVB8 of Defendants' E-Commerce Store, the Schedule A Defendant offers for sale and sells in the United States a product titled "AMBITFUL KN-21C 21inch 53cm Dimmable 3000~6000K Bi-Color LED Ring Light with Tripod and Phone Holder, with Remote, for Makeup, Selfie, Vlog, YouTube Video, Camera (2PCS)" ("Schedule A Defendant's Infringing Product") (Amazon.com's Infringing Product and Schedule A Defendant's Infringing Product herein collectively, the "Infringing Products"). (https://www.amazon.com/dp/B09GVSKVB8, accessed July 25, 2024). A true and accurate copy of the listing for Schedule A Defendant's

Infringing Product is hereto attached as Exhibit 3. The design of Schedule A Defendant's Infringing Product is shown below:



- 13.In the eye of an ordinary observer, the Infringing Products and the design claimed in the '668 Patent are substantially the same.
- 14.Upon information and belief, each of the Defendants imports and/or induces, aids, or authorizes others to import the respective Infringing Products from the People's Republic of China or other foreign jurisdiction(s).
- 15.Defendants' continued infringement of the Patent in connection with their offering to sell, selling, and/or importing of the Infringing Products into the United States,

including the offering for sale and sale of the Infringing Products into California, irreparably harms Plaintiff.

COUNT I

INFRINGEMENT OF THE '668 Patent

16.Plaintiff realleges and incorporates by reference the allegations set forth in the preceding paragraphs.

17.Plaintiff is an owner of the '668 Patent during its entire term.

18.Defendants offer for sale, sell, and/or import into the United States for subsequent resale or use the Infringing Products that infringe directly and/or indirectly the ornamental design claimed in the '668 Patent.

19.Upon information and belief, Defendants have notice of the '668 Patent, and their infringing acts are deliberate and intentional.

20.As a result of Defendants' infringement of the '668 Patent, Plaintiff has been irreparably injured, Unless such infringing acts are enjoined by this Court, Plaintiff will continue to suffer additional irreparable injury.

21.As a result of Defendants' infringement of the '668 Patent, Plaintiff has suffered, and continues to suffer, damages.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff Ji asks this Court to enter judgment against Defendants and grant the following relief:

1. A declaration that Defendants have infringed and is infringing the '668 Patent and a final judgment incorporation the same;

2. An order preliminarily enjoining Defendants and all persons and entities acting in concert with Defendants, from infringing the '668 Patent;

3. An order and judgment permanently enjoining Defendants and all persons and entities acting in concert with Defendants from infringing the '668 Patent;

4. An award to Plaintiff of total profits made by Defendants from their infringements of the '668 Patents pursuant to 35 U.S.C. § 289, or actual damages sufficient to

compensate Plaintiff for Defendants' infringement of the '668 Patent, together with prejudgment and postjudgment interest under 35 U.S.C. § 284;

- 5. A declaration or order finding that Defendants' infringements is willful and an award to Plaintiff of enhanced damages, up to and including trebling of Plaintiff's damages pursuant to 35 U.S.C. § 284, for Defendants' willful infringement of the '668 Patent;
- 6. A judgment holding that this is an exceptional case under 35 U.S.C. § 285 and awarding Plaintiff reasonable attorney fees, costs, expenses, and interest; and
- 7. Any and all other relief that this Court deems just and proper.

JURY DEMAND

Under F.R.C.P. 38, Plaintiff hereby demands trial by jury of all issues so triable by a jury in this Action.
